WAIVER AND RELEASE AGREEMENT

In consideration of participating in potentially hazardous activities as part of my experience with Alaska Big Game Safaris, which may include, but are not limited to, boating, flying in an aircraft either owned, leased, operated by or hired by Alaska Big Game Safaris, hunting, fishing, camping, hiking, backpacking or being transported by any type of motor vehicle, I agree as follows:

I hereby acknowledge and understand that the activities I will participate in with Alaska Big Game Safaris have inherent risks, dangers, and hazards that can potentially result in severe injury, sickness and/or death, such risks, dangers and hazards including, but not limited to:

1. Taking off, flying and landing in small aircraft including to and from remote airstrips;
2. Handling of firearms by myself and others;
3. Hiking, backpacking with heavy loads and camping in rugged, steep and remote backcountry areas;
4. Inclement, variable weather conditions, and avalanche potential;
5. Water hazards from boating and/or wading in the ocean, lakes, streams and rivers;
6. Encounters with biting and stinging insects and wild animals;
7. Risk of injury from transport in any motorized vehicle;
8. Experiencing a medical emergency in a remote backcountry location;
9. Traversing glacial and snow fields, talus slopes, and other dangerous backcountry areas.

I FULLY ACKNOWLEDGE, UNDERSTAND AND APPRECIATE THESE AND OTHER POTENTIAL RISKS, DANGERS AND HAZARDS OF VOLUNTARILY PARTICIPATING IN ACTIVITIES WITH ALASKA BIG GAME SAFARIS AND HEREBY ACCEPT ANY AND ALL RISK OF INJURY, SICKNESS AND/OR DEATH. I understand that in order to safely participate in these activities I require skill, knowledge and physical conditioning, I believe that I have the skill, knowledge and physical conditioning required to participate in such activity and that I have a responsibility to exercise this skill, knowledge, and physical conditioning. I have had the opportunity to discuss these activities and the risks, dangers, and hazards with a representative of Alaska Big Game Safaris and I am participating in this activity on a purely voluntary basis and I am electing to participate in spite of the risks, known and unknown.

I and my legal representatives, heirs and assigns hereby waive, release, and discharge Alaska Big Game Safaris, Todd M. Walton and his employees, volunteers, agents, and assigns from any and every claim, demand, action or cause of action, expenses (including reasonable attorney fees) of whatever kind or nature, either in law or in equity arising from or by reason of my death, or any damages, loss or injury, known or unknown, to me or my property resulting from my engaging in these activities, the use of Alaska Big Game Safaris, and/or its equipment or property or from first aid treatment or service rendered to me while participating in these activities.
